
Dear Mr. Hummel:

Also, please be advised that in accordance with RIGL §38-2-7² you have the right to appeal this response.

² R.I. Gen. Laws § 38-2-7. **Denial of access**

(a) Any denial of the right to inspect or copy records provided for under this chapter shall be made to the person or entity requesting the right by the public body official who has custody or control of the public record in writing giving the specific reasons for the denial within ten (10) business days of the request and indicating the procedures for appealing the denial. Except for good cause shown, any reason not specifically set forth in the denial shall be deemed waived by the public body.

(b) Failure to comply with a request to inspect or copy the public record within the ten (10) business day period shall be deemed to be a denial. Except that for good cause, this limit may be extended for a period not to exceed thirty (30) business days

B2013-7615-A: DIVISION 4, SECTION 13-99 Rights-of-way to the water.

On 11/03/09 at 0853 AM a report was made to the East Providence Engineering Division that you had installed a section of fence from your garage to the south blocking a city owned right-of-way. You are being ordered to remove this fence within the next 30 days.

Sec. 13-99. Rights-of-way to the water.

(a) No person shall block, barricade or in any way impede the public use of or access to designated public rights-of-way to the water as defined by the coastal resources management council or the city. See section 13-78, exhibit 13.

(b) No person shall store a vessel, vehicle or structure on a designated public right-of-way to the water as defined by the coastal resources management council or the city.

(c) Any person in violation of this section shall be subject to a fine in accordance with subsection 13-142(a). See list of rights-of-way, section 13-78, exhibit 13. A fine shall be collected each week until the violation is corrected.

You are hereby notified that you have the right to appeal this Notice of Violation by filing said appeal with the Harbor Management Commission within thirty (30) days of this notice in accordance with East Providence City Ordinance Sec. 13-82(5)(d).
